DIDACTIC REGULATION FOR THE MASTER'S DEGREE COURSE IN ECONOMICS

Introduction and area of competence

1. The present Regulation shall regulate the didactic organization of the Master's Degree Course in Economics LM-56 and, in particular, shall determine the elements required in the art. 12 of DM 270/04.
2. The present didactic Regulation of the Master's Degree Course in Economics LM-56, pursuant to the Didactic Regulation of the University, shall be approved by the competent didactic structure by majority and shall be approved by the Technical-Supervisory Committee.

I: PURPOSES AND DIDACTIC RULES

Art. 1 - Introduction

1. The present Regulation shall regulate the didactic organization of the Master's Degree in Economics LM-56 and, in particular, shall determine the elements required by art. 12 of DM 270/04.
2. The administrative authorities of the DC shall be the Coordinator (hereinafter referred to as CCdL), the Council of the DC and the Commission for the Didactic Coordination (CCD):
 - a. the Coordinator, a teacher appointed by decision of the Technical-Supervisory Committee and shall hold a coordinating function;
 - b. the Commission for the Didactic Coordination, with the purpose of promoting and verifying the quality and the unity of the teachings of the DC;
 - c. the Council of the DC shall be comprised of teachers who are entitled to at least one teaching.
3. The didactic rules of the DC, along with its general framework of formative activities, shall be reported in the attachment forming part of the present Regulation (Attachments 1-2).
4. The present Regulation, pursuant to the academic Didactic Regulation, and to the other didactic regulations, shall regulate the didactic organization of the Degree Course on the elements which were not defined in the aforementioned Regulations.

Art. 2 - Structure of the Degree Course

1. The DC belongs to the Faculty of Economics
2. The DC is organized into two years, provides for the acquisition of 120 formative credits (CFU) and aims to provide theoretical and methodological knowledge and competencies in the economic/business field. Upon completion of the studies, after having acquired 120 formative credits, the students shall be conferred the following study title: "Master Doctor in Economics". The DC aims to provide the students with characterizing knowledge and

competencies, in all the sectors of the economic/business field. The DC also provides methodological knowledge, ability to apply, in various contexts, the acquired knowledge and abilities in the English Language.

3. The didactic rules of the Master's Degree Course, along with its general reference framework of formative activities, the CFU assigned to each formative activity, drawn up according to a framework defined by ministerial decree and with due regard for the requirements of ANVUR, are contained in **Attachment 1**, which forms an integral part of the present Regulation.
4. The Master's Degree Course in Economics includes formative activities groups in the following typologies:
 - a) Characterizing formative activities;
 - b) Supplementary formative activities;
 - c) Optional Activities;
 - d) Activities related to the preparation of the final dissertation;
 - e) formative activities for the development of further linguistic competences, for eventual formative internships, IT, and relational abilities.
5. The course profiles of each formative activities shall be available on the website of the University, at the following "search for a member of the teaching staff" <https://www.uniecampus.it/en/students/search-for-a-member-of-teaching-staff/>

Art. 3 - Specific formative objectives and description of the educational path

1. The Master's Degree Course in Economics aims to provide the students with solid knowledge and competencies in the principal disciplinary/interdisciplinary sectors of economics: general and applied economics, business administration, mathematics, statistics, law; economic theory (even from a historical perspective); dynamics of economical development. With regard to the business sector, the DC shall perfect the basic knowledge acquired during the Bachelor's Degree providing in depth knowledge and competencies: strategic governance; business governance; organization reflexes for programming and management control; techniques and strategies for market analysis for the identification of a company's business. With regard to the mathematic-statistic sector, the DC shall provide competencies related to the measurement of economical phenomena, and for the support of decisions and politics of the public/private/no-profit sector. With regard to the juridical sector, the DC shall provide knowledge in commercial law and tax law so as to enable the students to carry out professional advice in the economics/business field. The DC shall also provide courses dedicated to the English language, so as to enable the students to enter the International labour market.
2. The DC shall be organized into one curriculum.
3. The present Regulation shall be completed with two attachments annually predisposed by the DC:
 - a. In **Attachment 1** shall be indicated the general framework of the formative activities;
 - b. In **Attachment 2** shall be indicated the formative activities proposed along with the list of

the teaching courses and the study plan;

- c. In **Attachment 3** shall be indicated the Faculty Guidelines for the Final Dissertation;
4. All the information required by the current legislation such as the formative objectives of the course of study and the activated formative activities, the list of the teachers involved in the DC, shall be published on the University website and on the Course Profile.
5. The programmes of the courses and the other formative activities, as well as the calendar of the exams shall be announced before the beginning of the academic year.
6. The formative activities, autonomously chosen by the student, provided for in Article 2 paragraph 4, letter c, shall be selected among the teachings indicated in **Attachment 2**, and shall not be submitted for the approval of the council of the Degree Course.
7. For all the questions related to the student's career and to the study plan, the students may address the tutors. The Degree Course shall provide tutors chosen by the University, representing a connection with the coordinator and the Council of the Degree Course.
8. There are no planned preparatory activities with regard to the education path.

Art. 4 - Learning Results

The graduates of the DC shall possess the following abilities:

Knowledge and comprehension

The Master's Degree in Economics shall provide courses in the field of Economics, Business Economics, Mathematics and Law, aiming to educate a professional figures with knowledge and abilities suitable for various labour contexts. The graduate shall acquire knowledge on the economical models, on the techniques of quantitative measurements of the economic phenomena, on the dynamics regulating the relationship between economics/development and the environmental factors. In addition, the students shall acquire knowledge and abilities in business management; governance; implementation of a business strategy; programming and control of marketing choices. The DC shall also provide knowledge and abilities in Tax Law and Commercial Law.

Applying knowledge and comprehension

The Master's Degree Course in Economics shall enable the students to apply the theoretical models assimilated during the learning pathway. The graduates shall be able to approach a great variety of economic phenomena analyzing them critically through the application of statistic instruments. The students shall also be able to plan strategic scenarios, to support governance choices, and to program corporate objectives following the development using accounting tools. The graduates shall also be able to apply the most adequate marketing techniques to specific business needs, as well as to carry out market research, to follow the life cycle of a business and to promote the most favourable conditions for business development. From a juridical point of view, the students shall be able to apply the rules regulating commercial and financial relationships. The acquisition of said abilities shall be evaluated through the examinations and through the final dissertation.

Making judgements

The course shall also enable the students to acquire a critical view on the complexity characterizing the economic and business system, and for the development of the ability to

observe and analyze the problems related to business administration. Said abilities shall be verified through the assessment of written/oral reports and of the final dissertation.

Communication Skills

The DC shall enable the students to communicate methodologically in order to transmit ideas, knowledge and techniques to interlocutors and specialists through an adequate terminology. The graduates shall reach said purpose through written and/or oral reports, as well as through the examinations and the final dissertation.

Learning skills

The students shall also acquire autonomy during learning pathway. The graduates shall also develop the ability to reflect critically on the learning subjects of the Master's Degree Course, so as to conduct autonomous in-depth research. The acquisition of the learning abilities shall be verified through interactive didactic tools, through the examinations and through the final dissertation.

Art. 5 - Professional figures, sources of employment and education prospects

1. Educational prospects: the graduates shall continue their academic career through second level Masters and the Research Doctorate.
2. Professional profiles and sources of employment. The graduates in the Master's Degree Course in Economics may pursue the following careers: experts in business administration, specialists in economic systems, expert accountants, market analyst, business consultants, tax consultants. The graduates may also register to the Registry of Qualified accountants, subject to the State Exam.

Art. 6 - Admission and enrolment

1. Shall be admitted to the Degree Course all the students with a Bachelor's Degree in the following classes: 28-17-39-19 (509/99); L33-L18-L15-L16 (270/04). Shall also be admitted all the students with an equivalent Degree attained abroad, deemed appropriate according to the current legislation.
2. The students who a Bachelor's Degree which does not belong to the aforementioned classes shall have acquired the following CFU:
 - at least 12 CFU in SECS-P/01 and/or SECS-P/02;
 - at least 9 CFU in SECS-P/07 and/or SECS-P/08;
 - at least 6 CFU in SECS-S/01 and/or SECS-S/06;
 - at least 6 CFU in IUS/01 and/or IUS/04;
 - at least 9 CFU in IUS/12 and/or SECS-P/03.

3. Without prejudice to the curricular requirements, for the purpose of the admission to the Master's Degree Course the students shall take an oral exam for the assessment of their personal preparation. In that respect the DC shall identify a dedicated evaluation committee.
4. Shall also be admitted all the students with an equivalent Degree attained abroad, deemed appropriate according to the current legislation.
5. The recognition of the CFU of the incoming students as well as the quantification of the minimum number of CFU that the students shall attain in an academic year in order to continue the course of study to another academic year, shall be established in the related Academic Regulations.

Art. 7 - Examinations and tests

1. For each formative activity shall be provided an examination, upon completion of the didactic activities represented by the learning objects present in the VLE.
2. The students shall acquire the CFU attributed to a particular formative activity only passing the examination.
3. The examination and the final evaluations needed for the attainment of the title shall not be more than 12. For the purpose of the calculation shall be considered the following formative activities:
 - a. Characterizing;
 - b. Supplementary;
 - c. Optional;
 - d. Related to the internship;
 - e. Related to the final dissertation;
4. The examinations shall consist in a test structured in conformity with what is provided for in the "Regulation for the implementation of the examination" and with due regard for the following rules:
 - a. The examination shall be organized so as to evaluate the knowledge, the comprehension, and the application of the examination subjects, demonstrating the proficiency of the student in the didactic units/thematic units of the related course.
 - b. The final evaluation shall take into account the results of the partial examinations, carried out with due regard for the Academic Regulations, in which case the teacher shall specify in the "course profile" the kind of activity, the modalities and the criteria of evaluation.
5. The professor in charge of the teaching, before the beginning of each academic year, and with due regard for the general regulation of the University, shall communicate the modalities for the examination, the assessment criteria and the possibility to carry out partial examinations. The manner in which the examination shall be carried out shall be the same for all the students with due regard for what has been established at the beginning of the academic year.
6. Eventual partial verifications shall not replace the final examination.

7. With regard to the implementation of the examinations shall be applicable the rules provided for by the Academic Regulation.

Art 8 - Duration

1. Shall be applicable the rules provided for by the Academic Regulation.

Art 9 - Mobility and studying abroad

1. The Master's Degree Course in Economics, in line with the provisions of the University shall promote the exchange of teachers and students through international cooperation and bilateral agreements. In this regard see the indications published on the website of the University on the International Cooperation and the Erasmus Policy at the following link:

Art. 10 - Final Dissertation

1. The final dissertation shall be written by the student with the supervision of a teacher of the Faculty of Engineering or of an external teacher entitled to one of the teachings provided for the Degree Course. The elaboration of the final dissertation, shall begin at least six months before the date estimated for the discussion, in order to guarantee its accuracy.
2. The discussion of the final dissertation shall consist in the presentation of a written dissertation realized by the student under the guidance of a supervisor with due regard for and with the procedures provided for in the related Academic Regulations and in the guidelines of the Faculty of Economics (see **Attachment 3**).
3. The final dissertation shall focus on any subject related to one or more formative activities of the following typology:
 - a. Characterizing;
 - b. Supplementary;
 - c. Optional.
4. The final dissertation may be written in a foreign language previously agreed upon with the supervising professor and the Coordinator of the Degree Course. In such case the student shall provide a detailed summary of the dissertation in Italian.
5. The final dissertation shall be discussed publically, shall be evaluated: 1) completeness and rigour of the dissertation; 2) methodology; 3) results of the dissertation. The dissertation shall be assigned maximum 8 points.

Art. 11 – Attainment of the Degree

1. The student shall attain the Degree with at least 120 CFU and upon completion and discussion of the final examination (final dissertation).
2. With regard to the conditions for the admission to the final dissertation, the degree examination board, the implementation of the examination and the final grade see the

Academic Regulation for the final dissertation.

3. The secretariat upon request, shall provide the graduate students with the Diploma Supplement, which shall describe the category, the level, the context, the content and the status of the studies carried out in accordance with the standard eight-point plan developed on the initiative of the European Commission, the European Council and of the UNESCO.

II - OPERATIVE RULES

Art. 12 - Obligations related to frequency

1. The student shall be admitted to the examination related to a determined teaching only after having implemented all the online learning objects making up the course, except for expressed and motivated waivers provided for by the teachers, who shall clarify them in their teacher's profile.
2. The DC provides for the enrolment as part-time student, for all the qualified students, pursuant to what is regulated in the Academic Regulations.

Art. 13 - Enrolment to the following years, transfer and withdrawal from the studies

Art. 14 - Recognition of incoming CFU

1. See the Academic Regulations.

Art. 15 - Dispositions for the students

3. The DC shall apply the rules provided for by the University regulating the frequency to the formative activities, the number of the credits to be acquired for the enrolment to the following course year; the requirements for the implementation of outsourcing education, and all the actions aimed at an effective learning. In this regard see the Student Regulation, the website page on the LDs and the Erasmus Policy of the University.

Art. 16 - Assessment of the Didactic Activity

1. The DC shall implement forms of assessment of the quality of the didactic activities provided for by the current legislation with the modalities and the deadlines provided for by the University's Quality Assurance Committee.

Art. 17 - Flexibility of the learning pathway

1. The Master's Degree Course in Economics, with the collaboration of the online tutors (OT) proposes orientation and tutoring activities in relation to the individual study plan, of the optional formative activities and with regard to the implementation of the curricular internship, promoting a student-centred approach to learning focused on encouraging the assumption of an active role in the definition and in the time frame of the learning pathway.

The DC shall promote a collaboration with the disciplinary tutors whom, coordinating with the teachers in charge of the course, shall have the task of supporting the preparation of the didactic materials and of the partial examinations, guaranteeing the possibility to implement flexible learning pathways. Finally, the student shall have the possibility to enrol in the DC and to take advantage of the formative offer at any time of the academic year and to carry out the examinations during the seven examination sessions, provided for in the academic calendar.

III - FINAL AND TRANSITIONAL RULES

Art. 18 - Amendments to the Regulation

1. Any amendment to the present Regulation shall be proposed by the Coordinator of the DC or by at least one third of the members of the Council of the DC or at least one third of the members of the Council of the DC and shall be approved by absolute majority and, successively, by the Technical Supervisory Committee.
2. In case of failure to approve the amendment, the proponent shall send a response, along with a report describing its motivations directly to the Technical Supervisory Committee.
3. The modifications to the present regulation, subject to the verification of their conformity to the Academic Regulations shall be issued by Decree of the President of the Technical Supervisory Committee.
4. Eventual legislative acts compatible with the Academic Regulation and incompatible with what is stated in the present regulation shall be applicable even in the absence of an expressed modification, but shall determine the immediate beginning of the procedure provided for in the first paragraph of the present article.
5. Eventual interpretive or applicative problems resulting from the succession of the Regulations in the course of time shall be the subject of a specific assessment on the part of the DC.

Art. 19 - Transitional regulations

1. The present regulation shall be applicable from the academic year 2018/2019.

GUIDELINES FOR THE ELABORATION OF THE FINAL DISSERTATION

The Final Dissertation shall be differentiated depending on the level of the Degree Course as follows:

- Bachelor's Degree Final Dissertation
- Master's Degree Final Dissertation

1. The Final Dissertation

The Final Dissertation shall be structured as an essay, and shall exemplify a comprehensive learning pathway for the Bachelor's Degree, while the Master's Degree Dissertation corresponds to a specialist learning pathway.

The elaboration of the final dissertation, shall consist in a detailed analysis of the study objects, demonstrating the assimilation of the logic-expositive style currently in use in the scientific community. The final dissertation shall be based on the personal inclinations and scientific interests of the students, identifying their personal position in relation to the reference literature, and demonstrating capacity for personal reflection and personal and creative elaboration.

The fundamental elements of a degree course are the following:

- The *object of study*, which may be subject to variations and/or improvements during the course of the research work.
- The *scientific approach*, consistent with the traditional approach to the object of study, which shall be improved and re-elaborated independently by the students.

On the basis of said elements it is possible to distinguish different types of final dissertation:

- *Theoretical Final Dissertation*, based on the discussion of the most relevant scientific articles on the research object;

- *Empirical Final Dissertation*, requiring application research activity, as well as the analysis on the scientific literature on the object of study. The original personal contribution of the student shall be recognizable as compared to the reference literature. By way of example, in a final dissertation based on an object of study of the economic-business field of expertise, the analysis of a case not yet published, shall comply with the requirement of originality.

2. Organization of the research activity

The elaboration of the final dissertation shall be divided into three major phases:

1. Preliminary research on the existing literature on the chosen object of study and creation of an outline, describing the thematic pathway.
2. Interaction with the teacher for the approval and eventual modification of the outline and provisional bibliography, and for the definition of a title (the form, duly signed by the teacher shall be submitted to the student secretariat six months before the graduation session).
3. Creation of the individual chapters of the final dissertation, which shall be submitted to the teacher's approval. In absence of a different arrangement, it is the practice that the student shall create and send one chapter at a time, waiting for the revision before continuing the research.

The submission of the application for the final dissertation shall be previously approved by the teacher, who shall grant authorization on the basis of the progress of the research activity. In the absence of a different arrangement, it is the practice that the teacher shall authorize the final dissertation if the student has carried out at least 50% of the research activity.

3. Articulation of the Final Dissertation and bibliographical references

The final dissertation shall comply with the following structure:

- Index
- Introduction
- Body of the dissertation divided into chapters
- Conclusions
- Bibliography

The pieces of literature (books, essays, articles, etc.) referred to in the dissertation shall be mentioned according to two modalities:

- A. Through the creation of a *footnote*, reporting for each consulted bibliographic source: author, title, place of publication, publishing company, year, page number.

EXAMPLE

- B.** Through the author-date method, which provides for the direct reference of the piece of literature within the text, thus avoiding the use of footnotes. The bibliographic references shall be structures as follows: ...text... (Drucker, 1995) ...text...

Esempi:

...text... (Drucker, 1995) ...text...

In case of contextual references to different pieces of literature by the same author and published in the same year, they shall be followed by a letter, following the alphabetical order:

text... (Drucker, 1993a; Drucker, 1993b) ...text...

In case of direct reference to part of the text, the student shall indicate the page number:

...text... (Drucker, 1995, p. 85) ...text...

4. Bibliography

The bibliographic references reported in the text shall be summarized in a bibliographic list (Bibliography), which shall report alphabetically the pieces of literature referred to in the dissertation.

The Bibliography shall comply with the following standard:

Magazine Articles:

It is recommended to pay attention to the bibliographic research, which shall be appropriate and detailed, selected in relation to the level of the Degree, as well as the approach and typology of dissertation.

5. *Anti-plagiarism check*

The supervising teachers have the institutional obligation (D.R. 29/7/2015) to prevent any plagiarism, declaring the “originality of the dissertation and the absence of any third party material”, by reason of the fact that copying part of a final dissertation constitutes an offence. In this regard, the supervisor shall necessarily check the text with an anti-plagiarism software, and deny the submission of any non-original dissertation.

4. *Editing criteria, abstract and further indications*

6.1 *Editing criteria*

The copies of the dissertation shall respect the following editing criteria:

- PAGE LAYOUT: dimension A4 (21x29,7 cm); upper edge and lower edge 3cm; left edge; right edge; 1,5 line spacing.
- FONT: Times New Roman; 12 pt.
- ALIGNMENT: justified.
- ORGANIZATION OF THE TEXT: the text shall be divided into chapters, paragraphs and subparagraphs enumerated in ascending order.
- PRINT: double-sided.
- BINDING: the dissertation shall be bound (the student may choose colour and typology of the cover).

6.2 *Abstract*

The students shall prepare an abstract of the dissertation describing explicitly contents, original contribution, as well as the conclusions of the dissertation, according to the following structure:

1. Name, surname, registration number of the student and title of the dissertation;
2. Index of the dissertation;
3. Summary (max 4.000 characters space included) containing:
 - Justification for the choice of the subject matter;
 - Methodology (for a research dissertation);
 - Summary of the contents;
 - Conclusions.
4. Bibliography.

6.3 *Further indications*
